### **FISCAL OFFICER**

I didn't see a reason why they need to be included. Renee will take them off. Haley is back and we went thru all the paperwork for the deposit account. We are off on the two accounts by \$55. We have everything organized for the clean up day. Still need volunteers if anyone is interested.

**POLICE** - Had three young girls helping to catch a dog. Chief gave girls a patch and a certificate. There was a complaint about our car sitting on Kelly McMasters. That is not our car. That is an old retired police car. Working on warrants, haven't found any of them yet. Vandalism at the trailer park. One overdoes, transported to Grady. Assisted Delaware county on Hanover Road, was cancelled before we got there. Lost property in Dublin Road in Delaware. They were shooting at a friends house and left firearm on top of car. Car drove thru Ashley, and we looked in our village and could not locate. Zach and Scott are both enrolled in online classes. Events; April 16<sup>th</sup> escorting the Easter bunny. April 30 – received 36 bike helmets. Will piggyback on the fishing event because there will be a lot of kids there. As for the June 11<sup>th</sup> clean up we will be around to help. Junk motor vehicles 216 W High. Sent a letter. Also spoke to Chris Mickie. 213 Center street. Working with the widow to get registrations changed over to her name to get these cars moved out. 219 Center Street still has not gotten trash picked up. Going to send them a certified letter to get the trash removed. Talked about the new law going into effect about anyone can carry a gun. Scott will check into the new law and give us more specifics later on.

### **ECONOMIC DEVELOPMENT/GRANTS** – We received a grant for the fishing tournament.

<u>PERSONNEL</u> – Renee indicated we need to add something to the personnel manual due to the police working 10 hours/day. If they work a holiday do they get 8 hours holiday compensation. Would like to thank the fire department for their donations and sergeants for the donations which paid for the trophies. We received a grant from ODNR for \$500. Jim wanted to know when the adults can fish? The tournament is over at noon and adults can then fish. We have 5 lifeguards and could use some more. Josie indicated that there is a pool training but not sure when it is. We have a form that we need to have the lifeguards sign saying they will work for the pool for two years.
