At this time, the kits arrive and leave very quickly so it is best to contact any library distributing before you arrive to verify if kits are in stock. The test kits are a hot commodity.

Beginning Wednesday, January 5th and for the following 5 Wednesdays, the library is partnering with OSU 4-H Extension Office and DACC to provide a coding class for 3rd to 5th graders. We have 9 participants who will learn how to code Sphero Bolts.
