Randy indicated that Mark and Jeff was able to work and they were exposed from the office. You can not get exposure from the office. You need to be exposed by a person. But there are two different things Randy is talking about. Jesse did indicate that the virus is still out there and if the VOA wants to do something for the employees now is the time to set something up. David Lockhart indicated that maybe we should allow 5 day pay for each employee. Cheryl indicated we need to specify hours since the police work 40 and the others work 35. For 2022 only that way we have a clear policy all across the board. Sounds like we have a motion by David Lockhart, and Jim Detter seconded. Jesse ask Randy if he wanted to use this time for when he was not working or use in the future if he would happen to get sick later? He indicated that he needed the pay now. Jesse ask if this satisfies his request and he indicated yes problem solved.

Jim indicated about the complaints we have received about customer service in the water department. His water was shut off and a little while later he came back with the \$20, but then he owed \$35 more to have the water turned back on. Jim Detter explained that haley's customer service needs to be written up and put in her file, so we have documents. It has been brought to Haley's attention and she stated she would try and do better.

<u>PARKS & RECS</u> – I think we a going ahead with the fishing tournament. Elaine indicated she will apply for the grant. It will be last Saturday in April. We will not have an Easter Egg hunt, but we have put a raffle in Feb and March's newsletter to sign up to win prizes. Easter Bunny will deliver prizes on Saturday, April 16<sup>th</sup>. Still need 2022 Lifeguards. 16 years and older. Skate park is a project on OHM Engineering list. Amee indicated that they have applied for the mini grant that the Health Dept was talking about.
